This Certificate was first issued on 2025-12-12 and will remain valid as long as the requirements that are laid down by the specified standard and technical regulations, to which the reference is made, or the method of product inspection applied by the Importer remain substantially unchanged, unless this Certificate is amended or cancelled by the AB.

At least once every 12 months, the Authorized Body carries out surveillance of proper functioning of product inspection at the Importer's premises pursuant to provisions of Section 5 (5) of the abovementioned Government Regulation, takes samples of the products and tests these, and assesses whether the characteristics of the products comply with the specified standard and technical regulations. The AB will issue a report on evaluation of the surveillance and pass it to the Importer.
